**DEFENDANT THE OHIO STATE UNIVERSITY'S
MEMORANDUM IN OPPOSITION TO PLAINTIFFS'
MOTION FOR LEAVE TO FILE REPLY BRIEF IN SUPPORT OF PLAINTIFFS'
MOTION TO CONSOLIDATE AND FILE REPLY BRIEF INSTANTER**

Plaintiffs seek leave to file a reply in support of their Motion To Order Joinder Of Parties, Or In The Alternative, To Consolidate Cases For Purposes Of Trial. Local Rule 4(C) states a reply "may be filed only upon a showing of the necessity therefore and with leave of the court." Plaintiffs' Motion for Leave fails to state why it is necessary that they be permitted to file a reply. Standing alone, this failure requires that it be denied.

Additionally, plaintiffs' proposed Reply is devoid of any case law, statutes, rules, or additional "evidence" supporting that this Court has jurisdiction to do what plaintiffs ask. As previously discussed by Ohio State, all authority on the issue actually prohibits what plaintiffs seek to do.

Plaintiff's Motion for Leave should be denied.


