
ENTRY

On July 9, 2014, defendant, Buehrer Group Architecture & Engineering, Inc. (Buehrer), filed a motion for an extension of time to respond to plaintiffs/counter defendants' first set of interrogatories and request for production of documents. Buehrer states that plaintiffs/counter defendants do not oppose the motion.

Upon review, Buehrer's motion is GRANTED such that Buehrer shall respond to the discovery requests on or before *August 11, 2014*.

On July 18, 2014, Hirschmann Construction Services, Inc., filed a motion for leave to file an answer to the Fourth Party Complaint. Upon review, the motion is GRANTED, such that any response shall be filed on or before *August 13, 2014*.

On July 23, 2014, defendant/counter plaintiff/third-party plaintiff, Jack Gibson Construction Co.
