Defendant State of Ohio hereby gives notice to this Court and Plaintiff as follows:

1. That Plaintiff Kwame Ajamu aka Ronnie Bridgeman was conveyed into the custody and control of the Ohio Department of Rehabilitation and Correction (ODRC) on January 8, 1976, after being convicted of aggravated murder, aggravated attempted murder, and aggravated robbery in Cuyahoga County Court of Common Pleas Case No. CR-20578 and aggravated burglary in Cuyahoga County Court of Common Pleas Case No. CR-20786;
2. That Plaintiff Kwame Ajamu aka Ronnie Bridgeman served his prison sentence for Case No. CR-20578 from January 8, 1976 to December 14, 2000;
3. That Plaintiff Kwame Ajamu aka Ronnie Bridgeman began serving his prison sentence for Case No. CR-20786 on December 15, 2000 and was released from prison on parole from January 27, 2003 to February 4, 2008;
4. That, Plaintiff Kwame Ajamu aka Ronnie Bridgeman attached to the Complaint a certified copy of the on February 11, 2015 Judgment Entry of Judge Shannon M. Gallagher in Cuyahoga County Common Pleas Court No. CV-14-837428 declaring Plaintiff Kwame Ajamu aka Ronnie Bridgeman "to have been a 'wrongfully imprisoned individual' within the meaning of R.C. 2743.48(A)" regarding Cuyahoga County Court of Common Pleas Case No. CR-20578; and

5. That, as a result of the February 11, 2015 Judgment Entry, Plaintiff Kwame Ajamu aka Ronnie Bridgeman was wrongfully incarcerated for a total of 9,108 days.
