FOR PLAINTIFF WILEY BRIDGEMAN

Defendant State of Ohio hereby gives notice to this Court and Plaintiff as follows:

1. That Plaintiff Wiley Bridgeman was conveyed into the custody and control of the Ohio Department of Rehabilitation and Correction (ODRC) on December 19, 1975, after being convicted of aggravated murder, aggravated attempted murder, and aggravated robbery in Cuyahoga County Court of Common Pleas Case No. CR-20436;

2. That Plaintiff Wiley Bridgeman was released from prison on parole from November 6, 2001 to May 6, 2003;

3. That Plaintiff Wiley Bridgeman was incarcerated in the county jail from May 7, 2003 to May 27, 2003, and was again released on parole from May 27, 2003 to June 10, 2003;

4. That Plaintiff Wiley Bridgeman was incarcerated in the county jail from June 11, 2003 to June 17, 2003, and he was returned to the custody and control of ODRC on June 17, 2003;

5. That Plaintiff Wiley Bridgeman was released to the custody and control of the Cuyahoga County jail on November 20, 2014, and, pursuant to an order from Cuyahoga County Common Pleas Court, he was removed from the ODRC rolls on November 21, 2014;

6. That, Plaintiff Wiley Bridgeman attached to the Complaint a certified copy of the on February 11, 2015 Judgment Entry of Judge Shannon M. Gallagher in Cuyahoga County Common Pleas Court No. CV-14-837428 declaring Wiley Bridgeman “to have been a ‘wrongfully imprisoned individual’ within the meaning of R.C. 2743.48(A)” regarding Cuyahoga County Court of Common Pleas Case No. CR-20436; and

7. That, as a result of the February 11, 2015 Judgment Entry, Plaintiff Wiley Bridgeman was wrongfully incarcerated for a total of 13,630 days.
