PLAINTIFFS' NOTICE REGARDING PAYMENT FOR PRELIMINARY JUDGMENT

The parties agree that Plaintiffs Kwame Ajamu (formerly known as Ronnie Bridgeman) and Wiley Bridgeman are entitled to a preliminary judgment for payment of 50% of the amount described in R.C. § 2743.48(E)(2)(b). The parties also agree that amount is \$51,901.58 per year in prison, or approximately \$142.20 per day. ($\$51,901.58 \div 365 = \142.19611).

The parties further agree for these purposes that Kwame Ajamu was wrongfully imprisoned for a total of 9,108 days. Thus, the total (E)(2)(b) award for Kwame Ajamu is \$1,295,157.60, and 50% of this award is \$647,578.80.

The parties further agree that Wiley Bridgeman was wrongfully imprisoned for a total of 13,630 days. The total (E)(2)(b) award for Wiley Bridgeman is \$1,938,186.00, and 50% of this award is \$969,093.00.

Plaintiffs request that the warrants of payment of the preliminary judgment be payable as follows:

- For **Wiley Bridgeman (\$969,093.00)**: Payable to “*Terry H. Gilbert, Attorney at Law, IOLTA for payment to Wiley Bridgeman for damages for physical injury,*” in care of Terry H. Gilbert, 55 Public Square, Suite 1055, Cleveland, Ohio, 44113.


